-We have received multiple (~6) coaches penalties/Bench Minors against coaches/parents on the bench. We have a zero-tolerance policy for speaking back to the referees. We need to support the Refs. There is no excuse. The only person to speak to the refs is the head coach. There is a process to make a complaint against a ref which needs to be followed.

-Junior B's would like ball boys for before games and will organize that with some of the younger players. It will be a feeder team for us.

-Put a bunch of Midget players through Level 1 coaching which is great step for our Junior Coaching program. We will explore this more for next year.

3.0 REF Allocator Report

-Entry Level Reffing Clinic

On May 7 Cam Comeau (of the BC Lacrosse Officials Association) and Keith Dunne (our Head Ref) held an on-floor clinic for our entry level referees. The clinic ran from 11:00-12:30 at Westhill and was followed by a BBQ. By all accounts it was a successful session and a great opportunity to help our newer refs figure out positioning on the floor and other skills they don't necessarily learn in the classroom.

A second clinic is planned for Level 1 and Level 2 referees on June 4 - also from 11:00-12:30 at Westhill, and also followed by a BBQ.

An important take-away from the first session is the need to hold these on-floor clinics earlier in the season before things get so busy. It's been a challenge finding floor time that works for our instructors and most of the referees. Next year we will try and do a refresher clinic for returning refs before the season gets underway and maybe look to hold a clinic for entry level refs shortly thereafter. A third clinic for everyone who is available later in the season would also be great if we can fit it in.

-Friendship Tournament

Referees have been assigned to all Friendship Tournament games. We only had to seek outside assistance for 6 games on Sunday afternoon, which is fantastic. The other 58 games are all being covered by our own referees.

Ref fees for this tournament will be significantly higher than in past years due to the cross-floor format for tyke games. We've scheduled one ref per cross-floor side for all mini-tyke games, but for many of the tyke games we'll have two refs per side. While this might seem like overkill, it's important to remember that there have been very few regular season tyke games this year, so a few of our new refs haven't reffed a game yet and others have only had one or two games. This tournament will give them much-needed experience so that we can move a few of them up to Level 1 next year.

-Referee Performance

I am incredibly impressed with our referees. With the exception of illness and scheduling changes due to their own games, they have all showed up at their games, on time and ready to go. Several of them have stepped up to fill last-minute openings, and they are all very responsive when I contact them. I'm giving some thought to a way to thank them all for the season and encourage them to come back next year. We could do a wrap up of some kind, maybe a BBQ at one of the lakes? If anyone has any suggestions, please let me know. **-Actions**

-Safety Person. Every team should designate a Safety person. It is not required for them to have extra training. This person should be available if there is injury. They are not there to decide if play on the arena floor is dangerous... that would be the coaches decision.

-At any point a parent can remove their player and then there is no fine with a short team. Player safety is paramount and if there is a fine the association would prefer that to playing in an unsafe situation.
