2.0 President Report

2.1 Feb Lower Mainland meeting

Allen updated that several clubs (including Port Moody) will be playing 3 on 3 in U9 while other clubs will play 5 on 5 in U9. Tournaments should be viewable around Mar 17 2023, and live for bookings by Apr 1st. Provincial locations have been decided. Goaltender exemptions based on height have been settled. Arbiter is the new ref scheduling system. Ref clinics have been scheduled. The 2023 season will start Monday Apr 10th, with 3 weeks of tiering. Suspension list will be provided shortly. The next regular meeting on Mar 15th will be the declarations.

2.2 Registration update

245 players are registered, as follows: U7 – 32 U9 – 30 U11 – 19 U11 Female – 11 U13 – 30 U13 Female – 19 U15 – 40 U15 Female – 17 U17 – 25 U7 Female – 17

Allen proposed running an indoor "try lacrosse" style of program for potential U7 and U9 recruits for next year.

Jamie proposed calling some of the second year U9 Female players to possibly consider playing U11.

Allen proposed the following U17 options:
1) Declare A2 team and release ~5 players based on evaluations
2) Declare B team and release ~5 players in registration order
3) Merge with Poco to create a true A1 team plus a B team

Motion tabled by Jake to approve option 1. All in favour, motion carried.

PMLA will explore options to integrate released players to a merged team with Poco.

Jake informed that tryout schedules have been created. Dates for Female rust removal should be established ASAP.

Allen commented that we should be considerate of players who play multiple sports during evaluations.
